DIL is looking for manufacturers/suppliers for supply of **Non-Torrefied Bio Mass pellets** on a long-term basis.

1. Brief Scope of Work:

The scope of work under this package shall include supply, loading, transportation and delivery of agro-residue based biomass pellets at Power Station site. The default mode of transportation is covered truck with the waterproof arrangement, however, the supplier may also offer transport by rail mode with the prior consent of the respective power plant management.
