#### **ABOUT DIL**

Dhariwal Infrastructure Limited (hereinafter referred as "DIL"), wholly owned subsidiary of CESC Limited, flagship power utility of RP- SG Group, has a 2X300 MW Coal based Thermal Power station at Chandrapur, Maharashtra. The units began commercial operation from 2014 onwards.

DIL invites Bids from reputed and experienced Bidders for Field Operation & Maintenance of Boiler, Turbine, Generator (BTG) and Balance of Plant (BOP) through two stage tender process.

The two stages of the tender are:

- 1. Pre-Qualification Bid along with supporting documents
- 2. Techno Commercial Bid, Earnest Money Deposit and Price Bid

Any change in this document will be published on the website of Dhariwal Infrastructure Limited (<a href="https://www.dilenergy.co.in">https://www.dilenergy.co.in</a>) under Tender. Bidders are advised to visit the aforesaid website regularly for updates. Separate individual communication will not be sent.

Under stage 2, DIL shall evaluate the Pre-qualification bid. Email notification & Tender document shall be sent to the qualified bidders. Bid submission details along with other terms & conditions shall be enumerated in the Tender document.

## 1. Brief Scope of Work:

Operation, Maintenance & Housekeeping of Boilers, Turbines, Generators, their Auxiliary systems and Balance of Plant including river water pumping, New Reservoir Pump, water treatment (viz. PT, DM, ETP, STP, CW system etc.) and their associated systems along with high Voltage systems, HVAC, Firefighting, all switchyards' etc.

Detailed scope of work and Terms & Conditions shall be shared in the Tender document.

#### 3. Minimum Qualifying Requirements (Pre-qualification criteria):

The Bidders shall essentially meet all the Qualification Requirements as under:

- i. The participating bidders should have minimum 5 Years of experience of Operation, Maintenance & Housekeeping of Boiler, Turbine & Generator (BTG) and Balance of Plant (BOP) in power plants, having unit size of 250 MW or above and station capacity of 500 MW or above.
- ii. The participating bidders shall have a currently valid O&M contract or contract completed within the last 6 months in a Thermal Power Plant with a minimum capacity of 500 MW or above.
- iii. Manpower strength (On roll manpower, highly skilled, skilled, semiskilled, and unskilled) on Bidder's roll should not be less than 200.
- iv. Bidder should have healthy financial condition to support smooth O&M services. Average Turnover in any 3 of last five years should be minimum INR 25 Cr.

All the above qualifications shall have to be accompanied by supporting documents.

## 4. <u>Pre-Qualification Bid Submission:</u>

#### 5. Bid (Tender) Documents:

Subject to fulfilment of the Pre-Qualifying Requirements mentioned above, the complete set of Bid (Tender) documents shall be issued to the qualified Bidders for subsequent submission of Techno-Commercial Bid, EMD and Price Bids.

#### 6. EMD:

Only Pre-Qualified Bidders, who are provided with the Bid documents, shall be required to furnish an EMD of INR 5 Lakh (INR Five Lakh only) through RTGS/NEFT/DD along with Techno-Commercial and Price Bids.

# 7. General:

- a) DIL may seek further documentary evidences from Bidders in support of fulfilment of the prequalification criteria.
- b) Subject to DIL being satisfied about the Bidder's capability to execute the work in totality, DIL may decide to relax one or more requirements at its discretion.
- c) DIL reserves the right to cancel/withdraw the Invitation for Bids without assigning any reasons and shall bear no liability whatsoever consequent upon such decision.
